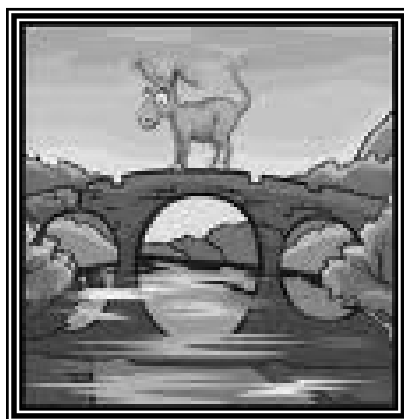

## Gulf Coast Donkey and Mule ASSociation Supreme Champion Sire Award Program

GCDMA will be awarding the coveted title of National Supreme Champion Sire to the miniature jack whose offspring being exhibited at this show accumulate the most points in halter. The aim of this award is to recognize Jacks whose offspring are exhibiting excellence in the show ring. The rules for nominating your sire are listed below.

# Supreme Champion Sire

*Nomination Fee: \$15.00 (submit with entry)*

### Rules:

1. Sire does not have to be shown but must be registered with ADMS.
2. You may enter more than one sire, or more than one group of offspring from the same sire, in any combination, but three must be designated on the form.
3. Submit copy of registration papers for Sire with Entry Form.
4. Designate three progeny (any age / jack, jennet or gelding) which will be exhibited in halter.
5. Submit the following information on progeny:
  - a. Registered name
  - b. Owner's name
  - c. Class name and number to be exhibited in
6. HALTER class's # 1 - # 14 to count. (specialty halter classes do not count) Points are accumulated as follows:  
1<sup>st</sup> place – 6 points, 2<sup>nd</sup> place – 5 points, 3<sup>rd</sup> place – 4 points, 4<sup>th</sup> place – 3 points, 5<sup>th</sup> place – 2 points, 6<sup>th</sup> place – 1 point

Ties Broken By: Most 1<sup>st</sup> places; then by most animals placed over; then by highest placing in their individual halter class

In consideration of permission to participate in this Event, I hereby waive all claims for damages or injury to myself or to my family and to indemnify and forever hold harmless the Gulf Coast Donkey & Mule ASSociation or, NMDA, any property owner of facilities included in the event, and their agents against any loss, cost or judgment of any nature for such damages or injury that might occur to myself or any member of my family who choose to participate in this event whether or not such damage is caused by negligence, carelessness, defects in equipment or facilities, whether latent or patent or by any other cause whatsoever.
